WAIVER, RELEASE AND INDEMNITY AGREEMENT  
FOR 2020 SUMMER SWIM PROGRAM

**ACTIVITY: RECREATIONAL SWIM AT PLYMOUTH AND IONE CITY POOLS**

In consideration of receiving permission from the Amador County Recreation Agency (“ACRA”) to participate in the above described activity, I, the undersigned, hereby waive, release, and discharge in advance any and all claims for damages for personal injury, death, or property damage which I may sustain or which may occur as a result of the my participation in said activity. This release is intended to discharge in advance ACRA and the Cities of Ione and Plymouth, their officers, employees, volunteers, or agents, from and against any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of active or passive negligence or carelessness on the part of ACRA or the Cities of Ione or Plymouth, their officer, employees, volunteers, or agents.

I understand participation in this activity potentially increases the risk of contracting the coronavirus known as COVID-19. That risk is potentially increased for many reasons including, but not limited to, the additional contact with others who are also participating, the use of shared equipment, and the contact with surfaces on the grounds or facilities used for or near the activity. This release is intended to extend to these risks and is intended to discharge ACRA and the Cities of Ione and Plymouth, their officers, employees, volunteers, or agents from any liability whatsoever association with COVID-19.

I understand that the described activity may be of a hazardous nature and/or include physical and/or strenuous exercise or activity; that serious accidents occasionally occur during the above-described activity; and that participants in the described activity occasionally sustain mortal or personal injuries and/or property damages as a consequence thereof. Knowing the risks involved, nevertheless I agree to assume all risks of injury and to release and hold harmless ACRA, the Cities of Ione and Plymouth, their officers, employees, volunteers, or agents who through active or passive negligence or carelessness might otherwise be liable to me. It is further understood that this waiver, release and assumption of risk is to be binding on my heirs and assigns.

I further agree to indemnify and to hold ACRA, and the Cities of Ione and Plymouth, their officers, employees, volunteers, and agents free and harmless from any loss, liability, damage, cost or expense, including attorneys’ fees, associated with or arising from my participation in the described activity.

**I have carefully read this Waiver of Liability and Indemnification Agreement, and fully understand its contents. I am aware that this is a release of liability and a contract between ACRA, the Cities of Ione and Plymouth, and myself and I sign it of my free will.**
