Please walk to the podium or listen to the conversation and speak when directed to by the Mayor if by phone. After receiving instructions from the Mayor, state your name. Proceed to comment upon the agenda item you wish to discuss. No member of the audience will be called upon to address the City Council on any subject during the time that the members are discussing the item. Following the discussion, and prior to the vote, the Mayor will recognize any member of the audience (Phone) who wishes to speak on the subject. Again, listen and wait to be called upon.

Your interest in the conduct of public business is appreciated.

- Those who wish to speak on agenda subjects scheduled as public hearings or discussions must fill out speaker information above. (This is while we are under a state of Emergency)
- Please limit your remarks to three (3) minutes. (**Resolution 2008-01**) **This will be strictly enforced due to limited access.**
- The audience in the council chambers will be required to be spaced out 6 ft or more and we ask that when you are done return to your safe space and/or exit the council chambers to allow anyone who might be waiting outside.
