Monthly water bills for water services shall be due and payable on the first day of the month following the close of the billing period, and shall be delinquent if not paid within fifteen (15) days from that date. Upon delinquency, a penalty of ten (10) percent of the balance due for that billing period shall be charged. When the water service is disconnected for nonpayment of any bill, service shall not be resumed until all prior charges have been paid in full, including the late penalty plus a twenty-five dollar (\$25.00) reconnection charge. **14.08.110** (amendments to the Plymouth Municipal Code supersede printed document)
