#### Acronyms you need to know

**PG&E:** Pacific Gas and Electric Company **CPUC:** California Public Utilities Commission

#### Why am I receiving this notice?

On March 1, 2024, PG&E joined other California gas utilities in filing an amended Hydrogen Blending Application<sup>1</sup> with the CPUC. The application requests \$94.2 million to support the state's clean energy goals through a project that will lower greenhouse gas emissions on natural gas systems.

#### Why is PG&E requesting this rate increase?

PG&E is committed to helping its customers safely and affordably meet the state of California's decarbonization goals. The application includes a phased approach to safely test adding hydrogen to existing natural gas pipelines, known as hydrogen blending. Using existing pipelines may be a cost-effective and timely way to transform California's future energy system and achieve decarbonization at scale.

#### How could this affect my monthly gas rates?

Bundled gas customers receive transmission, distribution and procurement services from PG&E. PG&E is proposing to recover gas costs over a 10-year period beginning **as early as 2027**. This assumes the application is approved and the projects are under way by this time.

In 2030, which is the year with the highest increase, the bill for a typical residential customer averaging 33 therms per month would increase by \$0.05 from \$73.49 to \$73.54, or 0.07%.

Actual increases will vary depending on usage and are subject to CPUC regulatory approval.

#### How does the rest of this process work?

This amended application is already assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt PG&E and gas utilities' amended application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding may review the amended application, including the Public Advocates Office. Public Advocates Office is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. #### Why am I receiving this notice?

On March 14, 2024, PG&E filed its Comprehensive Gas Advanced Metering Infrastructure Replacement Program application with the CPUC. The application requests \$497 million (0.1% increase for residential customers) to replace gas modules, which are necessary to provide accurate billing and usage data for customers.

#### Why is PG&E requesting this rate increase?

Modules are separately attached to gas meters to communicate usage data and are essential technology for basic gas operations. Many gas modules in PG&E's service territory are approaching the end of their expected useful life, and PG&E's proposal includes costs for replacement.

PG&E's proposal is proactive and is more cost-effective for customers than waiting until each module fails.

PG&E is proposing to recover electric and gas costs **beginning as soon as a final decision is issued by the CPUC**, **which could be as early as March 2025.** Starting in 2027, further costs will be included in the General Rate Case process.

#### How could this affect my monthly electric rates?

Even though the majority of costs are directly related to gas operations, there is still an impact to electric rates for certain costs common across gas and electric operations.

Many customers receive bundled electric service from PG&E, meaning they receive electric generation, transmission and distribution services.

In 2026, which is the year of the highest impact, the bill for a typical residential customer using 500 kWh per month would increase from \$222.92 to \$223.21, or 0.1% compared to current bills.

Actual impacts will vary depending on usage and are subject to CPUC regulatory approval.

#### How could this affect my monthly gas rates?

Bundled gas customers receive transmission, distribution and procurement services from PG&E.

In 2026, which is the year of the highest impact, the bill for a typical residential customer averaging 33 therms per month would increase from \$73.49 to \$73.96, or 0.6%.

Actual impacts will vary depending on usage and are subject to CPUC regulatory approval.

#### How does the rest of this process work?

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. # 8.1 CITY MANAGER'S REPORT

City Manager Roberts reported that the County Board of Supervisors approved a resolution giving us their Rule 20A credits for PG&E that added up to \$92,891 for underground wires in McGee Park. The City Leader Summit will be April 17-19<sup>th</sup> in Sacramento. She said if any of the council would like to attend, she would reserve them a spot. City Manager Roberts reported they had the first meeting with the Ione Band of Miwok Indians this week. She also thanked the council for allowing her to go on her family vacation in early March. City Manager Roberts mentioned that weather permitting we will be having a City sponsored Spring Family Fun Day on April 13<sup>th</sup> from 11-3pm.

# 8.2 MAYOR & COUNCIL MEMBERS' REPORTS

Council Member White thanked Mayor Staples for her attendance. He also wanted to clarify that in the past meeting he brought up bringing back phoning into meeting, not bringing back Zoom participation. He would like that point stated very clearly on record.

Council Member Sim has talked to Caltrans about a possible walking trail from Zinfandel Ridge and the Round-about. His hope is that it comes to fruition soon. Council Member Sim has also attended recent Amador Tourism meetings.

Mayor Akerland stated that she, Council Member Sim and City Manager Roberts met with some agencies and representatives regarding infrastructure. They talked about the water/sewer issues and the problems that have arisen due to the system being under a lot of stress. **RECEIVE INFORMATION ON THE PARK GRANT AND THE COSTS TO GIVE DIRECTION ON WHICH PROJECT TO COMPLETE FOR MCGEE PARK** 

#### BACKGROUND

Previously staff held two workshops and residents emailed in, and those present gave their ideas on what projects should be done at McGee Park and Lodge Hill. They thought it would be better to spend the money all at one park for a better project. They put the projects from 1-3 at each location. The projects were then brought to the City Council. The City gave their input and gave staff direction to get cost estimates on several options. The total grant funds available for the project are \$179,000, with a deadline of 07/01/2026.

Option 1: ADA access from Landrum Street. It would include a pathway of travel including stairs and ramps and handrails. The cost of this option is \$152,292.50.

Option 2: Bathroom remodel. Including making the restrooms larger, with new sinks. The cost of this option is \$68,000.00.

Option 3: Play Area Upgrade. This would include surface area replacement with safety soft surface and a 4-foot-tall black cyclone fence. The cost of this option is \$260,332.00, which is over the grant amount.

Option 4: Bench Seat around a tree: This would entail placing a bench around a tree with seating providing additional seating. The cost of this option is between \$5,000-\$7,500 to complete.

As you can see the costs vary and one project came in over the grant funds. The

Council could decide to combine projects or give direction to do something different; however, we do need to get started so we can meet the grant deadline.

# **ENVIRONMENTAL DETERMINATION**

Potentially no general fund fiscal impact if a project is selected within the grant proceeds. However, should the costs exceed grant funds there would be a general fund impact to that extent.
