A note from Margaret Roberts, Plymouth City Manager.

I can't believe April is already here!



Highlights of the March Council meetings include the following:

- Approved Minutes for two previous meetings
- Received the February Warrant Register
- Adopted a Resolution approving a contract for the Fire Station Improvement Project to LGM
- Construction for \$187,345.75; This contract is being paid using CV Grant funds.
- Authorized payment to the Amador County Sheriff's Office for two patrol cars for \$206,139.46. All but \$49,706.30 was approved in 2021 and all was paid using COPS Grant Funds.
- Received a report from the Sheriff's Contract Ad Hoc Commitee. Parameters were given for the next steps for the contract.
- Gave further direction on the Ione Band of Miwok Indian Initial Study/Mitigated Negative Declaration to meet and confer with the Tribe.
- Proclaimed March as American Red Cross Month.
- Received a presentation from the Amador Senior Center.
- Adopted a resolution granting consent to the County of Amador to form the Amador County Wine Heritage District.
- Received the Mid-Year Budget review and made Mid-Year budget adjustments.
- Received information and provided direction to place the City Clerk and City Treasurer positions on the November 2024 ballot to potentially convert from elected to appointed.
- Approved Pool operations and job classifications for Head Lifeguard, Lifeguard, and Recreation Aide and made the budget appropriation of \$20,000 for the 2024 Summer Pool Program.

Construction at the Fire Station on Sherwood Street will soon begin as they make repairs to the inside and outside of the station. The work is expected to take 45 working days. The City is getting new roofs on three buildings that are much in need; the Pool, and two buildings at the Waste Water Treatment Plant. The work is being done by LGM Construction.

The City is beginning the budget process for the 2024/25 budget year and there will be a workshop held for the public to provide input on the budget. We have also started doing a five-year projection which will help us to plan for projects that have been delayed due to lack of financial planning. There are street repairs that need to be taken care of and planned for without using reserve funds. The City needs to prioritize the limited funds that come into the City and having a five-year projection will help.

A list of projects with costs will be going to the City Council in April for the Council to choose which way to utilize the Park Grant funding. The choices that will be presented all came from the public meetings where input was provided, and the choices were summarized and prioritized by those present, then discussed by the City Council at a later City Council meeting.

The City Council has decided to take over pool operations this summer. The City will have a Pool Program this summer which will include group swim lessons and one on one swim lessons, lap swim and family swim. We are planning for night swim during the week at least one night a week and potentially twice. There will be a "snack shack" available with treats for patrons of the pool. We plan to have a different atmosphere at the pool and hope to have more people come out and enjoy the pool this summer. There are also other activities that are still in the planning stages that will be announced as they are finalized.
